BOOKING CONDITIONS

(please read carefully before signing)

THE CONTRACT

No contract shall arise until **Sportstours** or your travel agent have received this completed, signed booking form together with a deposit or full payment for the trip.

PAYMENT/PRICES

A non-refundable deposit of €100 per person is due when booking. Cancellation fees will apply - 25% before issue of tickets - 50% within 2 weeks of departure - 100% within one week of departure. The trip must be paid for in full 8 weeks before the scheduled date of departure. If the balance is not paid by that date, **Sportstours** shall have the option to cancel the package. Taxes are extra. We reserve the right to impose currency surcharges as necessary.

MATCH TICKETS

No duplicate match tickets are issued under any circumstances and no responsibility will be accepted for lost or stolen tickets. Match tickets are in the **HOME** supporters end, no **AWAY** supporters allowed.

ALTERATIONS BY THE ORGANISER

Sportstours are not responsible for any game changes which may arise during the season i.e. Sky TV, Champions League, FA Cup games etc. Should this situation arise **your deposit is non refundable**, you will have the option of choosing another game subject to availability. Additionally if we have to amend your flight times, any airline flight amendment fees will have to be paid. The minimum number of bookings per group is 20 persons. In the event of us not receiving the minimum number of bookings required, we are entitled to cancel or curtail the relevant programme at any time up to 4 weeks prior to the departure date and you as the consumer will not be entitled to make a claim for loss arising as a consequence of cancellation or curtailment in these circumstances. We will notify you within 7 days of any cancellation or curtailment necessitated by the foregoing circumstances.

COMPLAINTS

The Consumer shall be obliged to notify **Sportstours** in writing of any complaint not later than 7 days after returning to the point of departure or termination of the trip whichever is the earlier.
